Abstract

Despite the 20 years of economic transformation from the redistributive system (*razdatok*) to the market, the Russian modern housing policy has returned to the large-scale introduction of departmental and public housing and municipal mortgage (at reduced rate) for government employees. It resulted from the mechanism of market-razdatok equilibrium. In the course of historical changes in Russia it came through three institutional cycles. At structured phases of these cycles the razdatok turns out to be in the front while at the transformation stages a quasi market is formed. Both models generate significant outcomes but then face a crisis. This impasse is usually resolved by mutual replacement of these models. The new housing policy should synthesize market and redistributive (*razdatok*) mechanisms as indicated by the experience of welfare states' formation in the developed countries.

Into the Red: The Birth of the Credit Card Market in Postcommunist Russia	
(translated by Yury Kapturevsky)	30

The book «Into the Red: The Birth of the Credit Card Market in Postcommunist Russia» by Alya Guseva explores the emergence of credit card market in Russia and discusses how the demand for absolutely new product is created. The research is based on interviews and archival data collected in two series in Moscow (Russia): from 1998 to 1999 and from 2003 to 2005. The author finds out that the socialist legacies shaped the Russian credit card market development. This path-dependence of the Russian market resulted in non-trivial solutions discovered by the market actors trying to cope with uncertainty and complementarity as two critical factors. Social networks play an important role here as well. The journal «Economic Sociology» publishes the book's first chapter suggesting theoretical foundations for the empirical research.

«Grey» Importation over the Russian-Chinese Border:	What's New? 54

Abstract

The research aims at describing mechanisms and practices of «grey» importation of consumer goods over the Russian-Chinese border. It also demonstrates significant changes which happened over the last 10 years. The city of Blagoveshchensk (Amur region) serves as a case studied. Data covers in-depth interviews, observations, information from the website «Amur.info» and relevant legislation. «Grey» importation and shuttle trade are discussed from the standpoint of the new institutional economics and networks perspectives. The comparison of early and late 2000s business practices shows that applied «grey» business schemes are flexible and universal. In addition, there are important shifts in actors' status, role of Customs office and goods quality.
